Dear Leaders McConnell and Schumer:

As you negotiate future related relief packages for the ongoing coronavirus disease 2019 (COVID-19) pandemic, we would like to call your attention to the *Housing Survivors of Major Disasters Act*<sup>1</sup> and urge you to consider its importance to the immediate health and safety of thousands of households across the country, the efficacy of our nation's disaster housing relief programs, the ultimate success of ongoing recovery efforts in Puerto Rico and other parts of the country, and the responsiveness to future disasters as we enter hurricane season.

The COVID-19 pandemic has illustrated and exasperated longstanding financial, health, and housing inequities among the American public, as well as the persistent inequities between those in our territories and in the mainland United States. As you know, many of the inequities in Puerto Rico are fresh, stemming from the devastating impact of hurricanes Maria and Irma in 2017. Likewise, we are confident that you are aware of the sometimes unnecessarily bureaucratic nature of the housing relief programs we employ following natural disasters, including those provided in the *Robert T. Stafford Disaster Relief and Emergency Assistance (Stafford) Act.*<sup>2</sup>

To this day, the Federal Emergency Management Administration (FEMA) and Trump administration's apprehension to augment, support, and dutifully employ the Disaster Housing Assistance Program (DHAP) is having a disastrous effect on the people of Puerto Rico.<sup>3</sup> In response to a *Freedom of Information Act* (FOIA) request submitted by Oxfam, FEMA provided a portrait of an inexcusably prohibitive and archaic process that left tens of thousands of households without the aid they needed and deserved.<sup>4</sup> Many of the administrative burdens this program placed in front of victims would be addressed by our legislation, ensuring such a

So we reiterate our request that you work to include the *Housing Survivors of Major Disasters Act* in future relief packages under consideration in the Senate.
