Dear President Mackinnon:

I am writing to encourage your members to consider applying for a new round of federal grant funding for fire departments in Massachusetts.

I know that Massachusetts fire departments face funding challenges that can make it difficult for some to train and recruit new firefighters and maintain staffing levels that meet community needs. To address these needs, the Federal Emergency Management Agency (FEMA) recently announced that applications are now open for the Staffing for Adequate Fire and Emergency Response (SAFER) grant program, with approximately \$360 million in funding available for communities across the country.<sup>1</sup> The SAFER grant program provides funding directly to fire departments to help you hire new firefighters, retain current firefighters, provide training and education for firefighters, and purchase equipment and supplies.<sup>2</sup>

**FEMA's Notice of Funding Opportunity for this round of SAFER grants is currently accepting applications from fire departments nationwide, with an application deadline of 5:00 pm on Friday, April 12, 2024**. Career, volunteer, and combination fire departments with a "formally recognized arrangement with a state, local, tribal, or territorial authority … to provide fire suppression" services are eligible to apply for a SAFER grant, and I highly encourage you to submit an application for this funding opportunity.<sup>3</sup> FEMA will prioritize applications from fire departments who seek to improve compliance with National Fire Protection Agency standards.<sup>4</sup>

Since I was elected to the Senate, I have fought to secure federal funding for Massachusetts firefighters. Over the last decade, Massachusetts fire departments have received over \$270 million in SAFER and Assistance to Firefighters Grant funds.<sup>5</sup> Federal SAFER grants have been essential to shoring up funding shortfalls that dedicated Massachusetts fire departments have needed to ensure sufficient staffing and provide adequate training. For example, Belchertown received a nearly \$1.5 million SAFER grant in 2022<sup>6</sup> that enabled the town to hire six new firefighters and paramedics.<sup>7</sup> And the Worcester Fire Department received nearly \$23 million in SAFER grants in 2022 and 2023, enabling the department to hire 90 firefighters to address the city's fire suppression needs.<sup>8</sup>

I will continue to advocate for a longer-term, sustained stream of federal funding for the SAFER grant program. Federal SAFER grants are a key resource to ensure that firefighters—and the cities and towns you serve—are appropriately protected from fire-related dangers. I highly encourage you to make the most of the opportunity provided through FEMA's new round of SAFER grants, and look forward to working with you to bring this funding home to your community.
