v. Funding programs that train teachers to better educate our nation's children?

If confirmed, I commit to review all statutes, regulations, and outcomes and to work with Congress to determine the best way to deliver teacher training funding to the states.

vi. Monitoring federal student loan servicers?

If confirmed, I commit to review all statutes, regulations, and outcomes and working with Congress to determine the best way to monitor federal student loan servicers.

vii. Sponsoring research to help policymakers and teachers improve our nation's education system?

If confirmed, I commit to review all statutes, regulations, and outcomes and to work with Congress to determine the best way to sponsor education research.

3. Do you support preserving and expanding ED's current funding in future years?

If confirmed, I commit to review all statutes, regulations, and student outcomes and working with Congress to determine the most appropriate level of federal education funding.

 - a. Do you support the President's decision to grant DOGE staffers this unprecedented access to ED's data systems?

Recently, the Department extended the deadline for institutions to report data around FVT/GE because of software challenges, problems that arose when submitting previous data, and concerns about data integrity.

 - a. Will you commit to continuing any ongoing ED investigations into for-profit colleges?
